

Marston wind farm anger

West Midlands MEP Mike Nattrass has called on South Staffordshire Council to do the right thing and throw out plans for a wind farm in Staffordshire.

Plans to erect six 426ft wind turbines in Marston village near Stafford have prompted strong opposition from concerned residents in the picturesque rural area and from MEP Mike Nattrass.

Last November, members of the Stop Turbines Action Group (STAG) met with Mr Nattrass at the European Union Parliament in Strasbourg and following the meeting the MEP vowed to back the campaigners in their fight against the wind farm.

Mr Nattrass said: "These huge wind turbines would dominate the rural landscape near Stafford and property values would drop if this scheme is approved and implemented.

Members of the STAG campaign met

me in Strasbourg late last year and I was appalled to hear about the scale of this proposed wind farm. These wind turbines are simply not wanted by members of the community.

Last November I warned that the European Investment Bank (EIB) is providing new finance to support eligible onshore wind farm schemes. It has been confirmed that the EIB and two commercial banks are providing \$76 million towards the development of an onshore wind farm in Moray, Scotland.

EU interference is leading to these wind farms springing up all over the country. People in areas such as Marston do not want these blots on the landscape and why should they be dictated to by the EU? I hope this application is thrown out.

If you do the analysis and take away the subsidy, these wind farms are just not viable," he added. During a recent visit to the European Parliament in Strasbourg, opponents to the Marston plans received his support and encouragement to continue their fight.



Under Coalition Government plans recently published, every Local Authority has the opportunity to generate energy from wind and other sources using publicly owned land and buildings as sites for micro generation. Mike has contacted every LA in the West Midlands to enquire about their plans, and the responses are being collated.

Marston could just be one of many wind farms across the West Midlands, blessed with so called EU subsidy!

Flood defences fight in Warwick

When local resident Mrs Linda Bromley approached her MEP for help in October 2009, she had pursued a long and frustrating campaign against Warwick City Council and the Environment Agency for the reinstatement of degraded flood defences for her community in Emscote Gardens, Warwick.

The flood barrier had been built in the 1960s as a condition of the estate being built, but the Council had allowed it to become degraded and therefore ineffective. A local builder had requested planning permission for two houses which would further erode the height of the barrier and the Emscote Gardens Residents' Association then turned to Mike for help.

As a Fellow of the Royal Institute of Chartered Surveyors, Mike was fully aware of the impact of this situation on house prices, insurance valuations and saleability of these properties, and quickly responded to the residents' plight.

He was also appalled that the Environment Agency had

apparently failed to recognise their own assessment of the likely impact of climate change and therefore the increased potential for flooding of these houses. In the 1998 floods, the River Avon rose to within a few inches of the crest of the barrier; any future flooding could well spell disaster.

The local paper reported:

"Major victory for flood defence fight.

A concerted campaign against the further destruction of a flood defence in Warwick won a major victory thanks to MEP Mike Nattrass.

The Planning Inspectorate confirmed it had dismissed an appeal lodged by developers to build two houses on a 1960s flood defence in Mercia Way which lies alongside the River Avon.

Jubilant members of the Emscote Gardens Residents Association and UKIP West Midlands MEP Mike Nattrass welcomed the decision which has been hailed a victory for common sense.

In April, Mr Nattrass wrote to the Inspectorate on behalf of worried residents urging that the appeal be turned down as the houses would compromise a section of the flood bank near Emscote Gardens.

Following months of uncertainty the Inspectorate recently confirmed it had

refused the appeal.

The decision has been welcomed by MEP Mike Nattrass and by the residents who have led a long-running campaign against further threats to the flood bank.

Mike said: "The effectiveness of the flood barrier has been degraded over the years.

Now, following the Inspectorate's excellent decision to dismiss the appeal, the residents and I will continue our fight for the reinstatement of the flood barrier.

The Inspectorate's decision is a victory for common sense and a victory for the residents of Mercia Way."

Mike placed the residents' concerns in front of the Ombudsman, who agreed that the builder's appeal should be rejected and the Emscote Gardens residents were delighted when Mike was able to confirm that their battle from behind the fortifications was won.

NEWSFLASH

Tory EU Spin from the Party that proposed Romania into the EU

West Midlands MEP Mike Nattrass says the Tories' Birmingham Conference has underlined how the ConDem coalition cannot be trusted over Europe and has branded the proposed sovereignty clause 'pure spin'.

The MEP says the fragile coalition is clearly bitterly divided over the issue of Europe and that the Tories' record, which saw the party "re-Hague" on its promise to hold a referendum on the self-amending Lisbon Treaty, shows that the Conservatives will never stand up to the EU.

Mr Nattrass says the sovereignty clause will not be considered by the EU and will do nothing to stem the tide of EU rules and laws which render Westminster virtually powerless and shackle British business and enterprise.

Figures in the Official Journal of the European Union reveal, that since the Coalition government was elected in June, more than 850 pieces of EU legislation have been passed.

Mr Nattrass said: "Last December, the self-amending Lisbon Treaty was ratified which expanded the European Union's law-making powers. They may as well have opened Pandora's box and now it is too late to put the lid back on.

During the Tory conference, the Foreign Minister pledged to stand up for Britain's sovereignty but it was the Tories who "re-Hagued" on their promise to hold a referendum on the Lisbon Treaty, and it was the



Conservatives who signed the Maastrict Treaty.

Indeed, it was the Tories, in the person of Edward Heath, who got us into this EU mess in the first place, yet that party used its Birmingham Conference to spin the biggest yarn since the 1970s Tory fairy story about the Common Market and "no loss of sovereignty."

Now the Tories have the cheek to talk about a so-called "Sovereignty Clause" but at the end of the day the Lisbon Treaty is self-amending. The treaty expands the EU's law-making powers and restricts the power of Westminster. They may as well talk about a "Santa Clause!"

The treaty led to the appointment of the first president of the EU, Herman Van Rompuv, a man keen on an EU national anthem and the replacement of national symbols.



He wants the EU flag to fly in our schools, town halls and at sporting events and will fine us for non compliance. So much for sovereignty!

The Tories call on the British people to stand up for this country but the Conservatives and the Lib Dems fail to do so in Brussels and Strasbourg and vote it all away to the EU flag.

This sovereignty clause is a blatant publicity stunt. David Cameron's U-turn on holding a referendum on the Lisbon Treaty shows the Tories are committed to the EU project and signing away our country.

European Arrest Warrant should be scrapped!

The EU imposed European Arrest Warrant has led to countless miscarriages of justice. I am leading calls for British style justice and I have raised this issue on TV and Radio.

Thanks to interfering EU bureaucrats, the European Arrest Warrant overrules our own legal system and our own citizens have to suffer as a consequence.

The Edmond Arapi case highlights need for European Arrest Warrant system to be suspended pending an enquiry.

West Midlands MEP Mike Nattrass says the ongoing nightmare endured by Edmond Arapi shows the European Arrest Warrant system is flawed and should be suspended pending a thorough enquiry.

Italian authorities earlier this year dropped their European Arrest Warrant (EAW) against Edmond Arapi who works as a chef in Leek, Staffordshire.

Mr Arapi, married with three children, was facing 16 years in an Italian jail after being convicted in his absence of killing an Italian man in Genoa in October 2004.

Evidence, however, showed that Mr

Arapi was in the UK at the time of the murder.

The decision by the Italian authorities to drop the EAW against Mr Arapi was welcomed by UKIP West Midlands Mike Nattrass who says this case and also that of Birmingham City supporter Garry Mann, highlights a need for the EAW system to be suspended pending an urgent enquiry.

Both Mike Nattrass and fellow UKIP MEP the Earl of Dartmouth are campaigning for the enquiry.

Mr Nattrass said: "The cases of Edmond Arapi and Garry Mann highlight the deep flaws in the EU imposed EAW system.

I praise the Italian authorities' decision and I hope Mr Arapi and his family can put their ordeal behind them. I fear, however, that more cases like Mr Arapi's and Mr Mann's will arise as a result of the EAW system.

UKIP MEPs had recently written to the Home Secretary concerning the flawed EAW system and the cases of Mr Arapi and Mr Mann. All we are campaigning for is English style justice."

Garry Mann, a father of six from Faversham in Kent, is facing two years in a Portuguese jail despite British judges, police and the legal system expressing their dismay over how his case was handled by the authorities.

Fair Trials International branded Mr Mann's trial a 'travesty of justice' and a farce.

He was accused of taking part in a riot in Portugal during the Euro 2004 championships and within 48 hours of his arrest Mr Mann was tried and convicted.

Mr Mann claims that no proper interpreters were provided during his trial and he was only allowed to speak to a lawyer for five minutes before it began.

Our British tradition of justice is enshrined in landmark acts of fairness, such as the signing of Magna Carta in 1215, which gave everyone the right to a fair trial. The EU is riding roughshod over all our ancient legal safeguards.

West Midlands MEP Mike Nattrass has written to the Bishop of Birmingham calling for the disrespectful parking on historic gravestones at a City church to be stopped. The MEP, who is a member of the Church of England, has written to



the Rt Rev David Urquhart in an effort to stop car parking on Georgian and Victorian gravestones in St Paul's

Church yard in the Jewellery Quarter. $\,$

Mr Nattrass has spearheaded a longrunning campaign to find a permanent solution to the issue and preserve the gravestones for future generations.

Stephen Hughes, Chief Executive of Birmingham City Council, confirmed the local authority has 'no identifiable budget' to fund the cost of a \$20,000 project to end parking on the gravestones by relocating them to an appropriate site and resurfacing the area. But, Mr Nattrass says there is a simple, cost effective

ongoing saga. In his emails to Mr Hughes and Rev

answer to the

Urquhart, Mr Nattrass said: "There is no need to park on these ancient stones. There is room to park alongside without damaging them and without any cost other than the restoration of a chain between posts along the side of the stones.

It may well be that the gravestones in St Paul's Square were relocated in the 1960s but I doubt if the objective was to form hard standing for cars, 4x4s and vans.

The objective was to allow people to view these stones, not allow unholy ignoramuses to park heavy objects on them, so that ancient gravestones are broken up and oiled. Come on, this is the history of Birmingham which is being destroyed."

In a recent email to Rev Urquhart, Mr Nattrass said: "I am a member of the Church of England and I appeal to you to consider a problem which, in my view, is about the disregard of history, about disrespect and about vandalism – in other words desceration.

I suggest that the removal of the vehicles to an adjoining position and away from parking on these headstones is the simple answer."

German opposition to Bomber Command memorial is an insult

West Midlands MEP Mike Nattrass has expressed his anger over a German bid to scrap a memorial to Bomber Command and the tens of thousands who lost their lives fighting for King and country.

The MEP, whose father was an RAF WWII Lancaster pilot, says efforts by German politicians to stop a memorial being erected in central London are an insult to the brave 55,000 bomber aircrew killed in World War Two.

Veterans have expressed their disgust at the stance of the Bild

newspaper which recently ran a headline in English saying 'Please Say No', and efforts in Germany to stop the installation of the monument in London's Green Park.

Mr Nattrass said: "As the MEP covering the Coventry area, which was devastated by German bombing, I am appalled that some German politicians and the Bild newspaper are actively campaigning for the monument to be scrapped.

How dare they! Many people in Bomber Command lost their lives to defend this country. At the end of the day they bombed us and we bombed them.

To quote Sir Arthur 'Bomber' Harris,

who was in charge of RAF Bomber Command:


'The Nazis entered this war under the rather childish delusion that they were going to bomb everyone else, and nobody was going to bomb them. At Rotterdam, London, Warsaw, and half a hundred other places, they put their rather naive theory into operation. They sowed the wind, and now they are going to reap the whirlwind.'

Indeed, the devastation of Coventry, within my constituency, led to the Germans' creating the word 'Coventrate', meaning to devastate sections of a city by concentrated bombing. The Germans called for 'Total War' and they received the final dividend that is now history.

It is nothing short of a national disgrace that there is no monument to Bomber Command and I join veterans in calling for this disgrace to end.

Many brave airmen made the ultimate sacrifice to defend this country. It is also a fact that "Bomber" Harris was the only Chief of Staff to be denied an honour at the end of the war. That was an insult to all who served in Bomber Command."
